1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
2 Statutes, in registration of vehicles, further providing for
3 display of registration plate.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Section 1332(d) of Title 75 of the Pennsylvania
7 Consolidated Statutes is amended to read:

8 § 1332. Display of registration plate.

9 * * *

10 (d) Validating registration stickers.--Validating
11 registration stickers shall [~~not~~] be issued [~~or~~] and shall be
12 required to be displayed. The following shall apply:

13 (1) The department shall issue validating stickers upon
14 renewal of a vehicle registration or, if the vehicle
15 registered had a temporary registration, to indicate that
16 registration has been completed and the temporary

1 registration status terminated.

2 (2) A validating sticker shall be affixed to the
3 registration plate of the vehicle for which the validating
4 sticker was issued.

5 (3) A renewed registration may not be considered
6 validated for the new registration period until the
7 appropriate sticker is attached as provided under paragraph
8 (1). A temporary registration may not be considered validated
9 for a succeeding registration period until the appropriate
10 validating sticker has been attached as provided under
11 paragraph (2).

12 Section 2. This act shall take effect in 180 days.
